Operations

Health Screening

Committee: Dr. Shumate, district nurses, teachers, principals and community members.

Outside the building:

WHO:

- Staff expected to self-screen at centralized, designated stations upon arrival, prior to accessing their work space.
- Walk-up students Multiple stations with seasonal coverings set up
- Drop off students Screeners will be curbside to meet cars and screen students in their cars.
- Bus riders- Screened on the bus upon arrival at the school.

Health Screening, Continued

HOW:

- Screening team, consisting of staff designated by administrator and trained by Health Services, in appropriate PPE, conducting screenings at arrival to school, such that no staff, student, or community member will be admitted to the building without screening.
- Screening stations set up in strategic locations to maximize flow through for: walkers, bus riders, student drivers, and students being dropped off
- Temperatures taken by screeners on arrival at school.
- Attestations taken on site for secondary, and done per parent in advance for Elementary
- Exploring technology via current Skyward database or phone app to expedite process
- There will be visual inspection for overt symptoms by screeners

Health Screening Continued

Once inside the building:

- Prior to school, parents will receive and sign a document detailing illness policy and explaining their responsibility to keep ill students home
- Each school will now have a designated Isolation Room with negative air flow and a Treatment & Med room for injuries and medication administration
- Each health room will now have a mobile health station on wheels
- Students in isolation to be cared for by building nurse or trained health room staff
- Teachers will have symptom specific passes for students being sent to the health room
- Contact tracing to be done by building RN with Island or Snohomish County Health Departments
- Letters and family contact regarding exclusion or isolation will be made in coordination with local health departments
- System for tracking exclusions to be managed by Health Services staff, and accessible by administrators and attendance secretaries
- HIPPA will be maintained for all students and staff

Safety/PPE

- We have purchased adequate face coverings and other PPE requirements to protect all staff and students in each building.
- Face coverings: Adult and youth cloth masks, adult and youth disposable masks, adult and youth face shields, clear masks for specialists.
- Cooperative Purchasing Agreement through ESD 112-masks-cloth and disposable (adult/youth), face shields, gloves, hand sanitizer, disinfecting wipes.
- No touch hand sanitizing dispensers for all classrooms without sinks and at school entrances. Additional hand sanitizer for all teachers and classrooms.
- UV Sanitizers, desk shields, plexiglass, health room dividers, signage.

Food Service

- The USDA has not issued all of the waivers that are in effect for the summer feeding program.
- The district will offer meals to students only and track as full paid, free or reduced.
- Grab 'n Go Bags
- Elementary planned to eat in their classroom.
- Secondary planned to eat in various locations around the building.
- Meals will be offered to students in Continuous Learning. The waiver has been issued for multi-day feeding.

Transportation

- Staff will be screened prior to entering building.
- All drivers will wear face masks.
- All students will be required to wear face mask before loading the bus. If they do not have a mask, one will be provided.
- Students will load bus back to front to avoid exposure.
- Windows will be opened for better circulation.
- Siblings will be encouraged to sit together.
- Upon arrival at the school, a health screener will board the bus and screen students prior to unloading.
- Buses will be cleaned and disinfected after AM and PM runs.

Maintenance - Cleaning, Disinfecting, & Ventilation

- All schools will be cleaned and disinfected throughout the day and after students leave.
- Wednesdays will be for deeper cleaning and disinfecting and weekends if necessary.
- Equipment/supplies purchased electrostatic handheld sprayers, Alpha HP Disinfectant, staff training
- HVAC equipment cleaning, servicing, changing filters balancing of systems
- Ventilation operation, air flow, exhaust fans
- Industrial Hygienist Visitation
