Washington State Department of Health "Learn to Return Program" (formerly

"Test to Stay Program")

TYPE: Action Required

At the October 5, 2021, regular board meeting, the board approved the Memorandum of Agreement with the Snohomish Health District for the "Test to Stay Program."

While the following agreement is unchanged, the reference to this program for audit and accounting purposes is now "Learn to Return Program." Therefore, the agreement is being placed on the November 23, 2021, Consent Agenda to formally note the reference "Learn to Return Program," for audit and accounting purposes.

Island County Public Health is on board with this program as well and Island County Health Officer, Dr. Howard Leibrand, has added his signature to the Snohomish Health District agreement.

As stated in the October 5, 2021, board memo, the Stanwood-Camano School District has secured a grant through the Snohomish County Health District for (up to) 2 Full Time Equivalent (FTE) staff to support our efforts in reducing the spread of COVID in schools through the "Learn to Return Program." The Washington State Department of Health has provided optional strategies for school districts to utilize in order to permit students with close contacts to remain in school. The "Learn to Return Program" allows close contacts to stay in school during their modified quarantine period.

RECOMMENDATION:

That the Board approves the Memorandum of Agreement with the Snohomish Health District regarding the implementation of the Washington State Department of Health "Learn to Return Program."

MEMORANDUM OF AGREEMENT BETWEEN THE SNOHOMISH HEALTH DISTRICT ("SHD") AND STANWOOD CAMANO SCHOOL DISTRICT ("DISTRICT") REGARDING THE IMPLEMENTATION OF THE WASHINGTON STATE DEPARTMENT OF HEALTH "TEST TO STAY PROGRAM"

WHEREAS, the Washington State Department of Health (DOH) has provided optional strategies for school districts to utilize in order to permit students with close contacts to remain in school; and

WHEREAS, a school district must adopt the DOH Test to Stay Program to allow close contacts to stay in school during their modified quarantine period; and

WHEREAS, prior to adopting this program, the school district must receive approval from their local public health jurisdiction; and

WHEREAS, the Parties wish to formalize the terms under which SHD approval will be granted.

NOW THEREFORE, the Parties hereby agree as follows:

- District Supervision. To participate in the Test to Stay Program, the District must identify a COVID-19 Coordinator/Supervisor. The following individual is hereby identified by the District:

 - Collect consent and registration forms from parent/guardian of students.
 - Inform participants that they must still quarantine outside of school and cannot participate in extracurricular activities, after-school activities or social gatherings until their modified quarantine period is complete, they remain symptomatic, and they have tested negative at least 5-7 days after last exposure.
 - Perform testing at school. Tests conducted at home by the parent, guardian, or individual will not be accepted.
 - Use the test specified by the District (e.g., rapid antigen, pooled viral test).
 Please indicate testing type and expected cadence: Abbott BinaxNOW
 We will test immediately upon designation as a close contact, then in the 5-7 day window.

- Have a Certificate of Waiver MTS/CLIA license (if applicable based on test type above). License number: 50D22077622
- Report all test results, both positive and negative, to SHD within 24 hours of testing.
- Follow the DOH Test to Stay protocol with at least two tests: one conducted as soon as possible following recognition of the exposure (i.e., the same or next school day) and one collected 5-7 days after last exposure. If testing is not conducted per this schedule, individuals must follow standard quarantine guidance.
- Correctly identify who can participate in the DOH Test to Stay Program. Students exposed outside of school (e.g., household exposure, private sports league exposure, etc.) are not eligible to participate. They must quarantine at home and follow the standard quarantine imposed by SHD pursuant to prevailing DOH and CDC guidelines.
- 3. Revocation. The District understands that authorization to participate in the Test to Stay Program is conditional and may be revoked at any time by the Health Officer should they, at their sole discretion, determine that COVID-19 infection/transmission rates are such that a modified quarantine program and testing are inadequate to prevent the spread of COVID-19 or that its implementation by the District is not satisfactory due to failures in one or more of the items set forth above.
